OUTING AGREEMENT

Butte des Morts Country Club, Inc. will be available for golf outings on Mondays (and some Tuesdays) only. Butte des Morts Country Club, Inc. will make every attempt to hold Monday dates for any group that holds their outing on an annual basis for 30 days after the date of this letter. After such time, the date will become available to anyone else that would be interested, either Member or Member-Sponsored.

FORMAT:

A shotgun start will be required if your group consists of 72 players or more. A maximum of 144 players will be allowed on the golf course at one time. Groups with fewer than 72 players may be approved, however the group may be required to share the golf course with other golfers and also may be required to use tee times. Please contact our Golf Professional, Jason Wachtl, at 738-5544 to coordinate the tee times.

Shotguns may begin play at 8:00 a.m. or between 11:00 a.m. and 1:00 p.m. Groups that guarantee less than 72 players are subject to being paired with other groups. Groups that guarantee 72 players and fall below that number are required to pay for 72 players, unless they notify the club in writing a minimum of 120 days prior to the outing. **Initial here** _____

BUTTE DES MORTS GOLF OUTINGS

FINANCIAL OBLIGATIONS

The **current** cost per player for a one day event is \$_____ plus tax. This fee includes:

- 1) One 18 Hole Green Fee*
- 2) 1/2 Power Golf Car.
- 3) \$13 per player retail pricing in golf shop merchandise.
- 4) Use of the practice facilities on the day of the event.
- 5) Locker Room Services.

**The host BDM golfing members' green fee portion will be comped. All other participants will be charged the full fee.*

GOLF CARS:

Golf Car usage is strongly recommended of all players unless weather and golf course conditions will not allow the safe use of golf cars. This decision is at the discretion of the Butte des Morts Management Team. If golf cars are not used, the fee is reduced to \$75 plus tax per player.

CANCELLATION AND RAINOUT POLICY

Should circumstances beyond human control (such as inclement weather, acts of God, etc.) cause Butte des Morts Country Club to cancel this event prior to the scheduled date, each participant will be given a voucher good for one eighteen hole round of golf including the use of 1/2 of a power golf car, and a bag of practice balls at Butte des Morts Country Club Inc. This voucher will be good for 12 months from the date of the originally scheduled golf outing and cannot be used for future golf outings.

Should circumstances beyond human control (such as inclement weather, acts of God, etc.) cause Butte des Morts Country Club to cancel the golf portion of the event the day of the event, each participant will be given a voucher good for one eighteen hole round of golf including the use of 1/2 of a power golf car, and a bag of practice balls at Butte des Morts Country Club Inc. This voucher will be good for 12 months from the date of the originally scheduled golf outing. (If additional golf cars have been delivered, the group must cover the expense of delivery); the food and beverage portion would still be available and shall also be paid for by the group.

Should circumstances beyond human control (such as inclement weather, acts of God, etc.) cause Butte des Morts Country Club to cancel the event after the start, but before the completion of 9 holes, each participant will be given a voucher good for one eighteen hole round of golf including the use of 1/2 of a power golf car, and a bag of practice balls at Butte des Morts Country Club Inc. This voucher will be good for 12 months from the date of the originally scheduled golf outing. (The food and beverage portion shall be paid for by the group). The completion of 9 holes will be considered a complete round with the group owing Butte des Morts Country Club full fees.

Modifications may be made to this agreement only if it is in writing and signed by both the Group and Butte des Morts Country Club.

CLUB POLICIES

DRESS CODE

Appropriate Country Club attire is required of all participants.

Men's Shirts – Men must wear a collared shirt or mock neck shirt. Tank tops, sleeveless and tee shirts are not considered appropriate. Shirts must be worn at all areas of the clubhouse, practice range, and golf course.

Men's Pants – Must be tasteful and not in disrepair. Jeans, cut-offs, jogging shorts, running shorts, tennis shorts and bathing suits are not permitted.

Men are requested not to wear hats, visors, etc. in the clubhouse.

Women's Shirts – Women must wear a collard or mock neck shirt. Tank tops, tee shirts and halter tops are not permitted. Sleeveless shirts without a collar, may not have a scoop neck.

Women's Pants – Must be tasteful, not in disrepair and proper length. Proper length will be defined as no more than 7 inches above the top of the knee cap. jeans, cut-offs, jogging shorts, running shorts, tennis shorts, bathing suits and short shorts/skirts are not permitted.

Shoes and proper attire must be worn at all times in the cocktail lounge and the dining rooms.

Our Club Management Team and Club Professional strictly enforce the above rules concerning dress code.

OTHER BDM CLUB POLICIES:

Each player must have his or her own set of golf clubs. Two players playing out of one bag is not permitted. Contact our Golf Professional if you will need rental sets.

Our pace of play policy allows 4 hours and 20 minutes for an 18 hole round of golf. This pace of play policy may allow for more time if the size of the outing exceeds 100 players.

All golf outings are limited to 18 holes of golf and players are limited to playing one ball per hole. Any special requests to deviate from this policy can be submitted in writing to the Board of Directors prior to signing a contract.

Please use proper golf etiquette at all times. Replace all divots, repair all ball marks, and rake all sand traps.

Players must be 18 years of age, and possess a valid driver's license to operate a motorized golf car. Only 2 players may ride in a golf car.

Please observe where golf cars are permitted to be driven. Keep golf cars at least 30 feet outside the lined areas around each of our greens and out of the long grass areas. Any damages to a golf car or other property of Butte des Morts Country Club will be billed in full to the golf outing or the outing sponsor.

On The Course – If you have hold sponsor signs or on the course events (such as closest to the pin, etc.) the golf staff will place and retrieve those items on the course. Any other items or people that need to go on the course will be the responsibility of the event to put them out and retrieve them. You may rent additional golf carts at \$40 per cart to help with this. **Requests for extra carts must be made at least (7) days in advance of the event.** Carts reserved for players will not be available to use.

Hole In One – Below is the maximum yardage the par 3's will play at. Make sure your hole-in-one contracts read accordingly:

#5	165 Yards
#7	150 Yards
#12	125 Yards
#17	95 Yards

All approved outings have the benefit of reserving a portion of the golf course for the day of their event. Consequently, all approved outings are required to pay the outing rate regardless of how many members end up playing in the event (currently, only the host BDM golf member is exempt from paying the green fee portion of the outing fee).

All food and beverage is to be consumed on our property and must be purchased through Butte des Morts Country Club, Inc. Donated food and beverage that could be consumed on club property must be approved by the Club Manger.

We recognize the purpose of corporate entertaining and sponsorship; however, we retain the right to limit use of signs, displays and/or advertising on club property.

This agreement will ensure that your outing will run smoothly.

GUARANTEE

If the above date and information is acceptable, please return a signed copy of this contract with a **non-refundable deposit** of \$2000.00 in the form of Cash or Check within 14 days to hold your date. If your event is cancelled, this deposit is forfeited in its entirety. In addition if you cancel your event within 60 days out of the event, you will be responsible to pay for 50% of the minimum number of golfers; 30 days out of the event you are responsible to pay for the minimum number of golfers. Initial arrangements and Food and Beverage contracts must be completed 30 days prior to this event.

All events are expected to pay within thirty days of the event.

Guarantees:

Food and Beverage: A guaranteed number for lunch and dinner needs to be given 72 hours (6 days) in advance.

Golf Count & Player List A final count for golfers must be provided to the golf professional 7 days in advance of the event. Call the golf shop at (920)-738-5544 or email at jwachtl@buttedesmortscc.org to provide a final count. This will be the minimum number of participants the event will be billed for. The final player list must be provided to the golf professional 2 days in advance of the event. This should be emailed to jwachtl@buttedesmortscc.org in the requested format.
